- Mere payment of examination fee shall not be the eligibility to appear for examinations.
- The examination fee once paid shall not be refunded to the candidates.

- (v) The students who are writing one-time chance exam and having low internal marks shall be given only one chance to improve their internal marks. Registration for CBT exam for internal improvement for all eligible candidates is mandatory.
- (vi) Applicants should enclose the photocopies of latest marks memo containing failed subjects or attach the online portal copy highlighting the backlog subjects
- (vii) The duly filled in applications should be handed over in the examination branch.
- (viii) Lab/ Project Viva examinations are to be conducted from 03-10-2024 to 05-10-2024
- (ix) Hall Ticket shall be issued to students after fulfilling all eligible conditions.
